Application permitted by Development Management Committee on 19th May 2016 with conditions on time to implement, but no decision notice yet issued.
To consider action about failure by AVDC to issue a decision notice despite the committee decision over a year ago.
- (b) Planning application 15/00195/APP
For: The erection of 44 dwellings with access, parking, landscaping, open space and associated works At: Land south of Whaddon Road
Application submitted and validated on 23rd January 2015 but not yet determined.

(c) Planning application 17/01107/AOP
