Questions asked proposed development at Whaddon ("Shenley Park"); over-hanging trees along Bletchley Road; and about what is happening on Old Buckingham Road; tidying memorial plaques at the PC burial ground; Thanks to Cllr Whipp for attending coffee morning at Free Church; potential of latches being fitted to play area gates; hedge along Drayton Road (due to be cut on 8<sup>th</sup>/9<sup>th</sup> October); hedge along Drayton Road (after 40 mph sign) which is obscuring visibility.
