**Planning and Highways**

**22/20 Salden Chase (South West Milton Keynes) Planning application and appeal**

To note appeal against refusal by Milton Keynes Council on planning application 15/00619/FUL "Salden Chase" (South West Milton Keynes) and current situation on identical AVDC application 15/00314/AOP (committee resolution to approve on 17th June 2017, but not yet determined and no agreed section 106 agreement).

Steve Heath gave a presentation on the Transport Assessment submitted with the appeal.

Solicitor Bob McGeady joined the meeting, gave an outline from the legal point of view and answered a range of questions.

**23/20 To consider action to be taken on Salden Chase planning applications and appeal, including legal, planning and highways consultancy support.**

**Resolved** to make a budget provision of up to £10,000 to support a challenge to the appeal on Salden Chase planning application, as well as any action required in relation to the outstanding application with Buckinghamshire Council. To include specialist legal, highways and planning input as necessary. Action to be taken jointly in conjunction with West Bletchley Council, and if they agree to participate and be jointly represented Milton Keynes Council. That the clerk be delegated authority, in conjunction with the chair and vice-chair to approve expenditure up to the approved amount.

**24/20 To consider revised proposal Project Initiation Document (PID) from Transport for Bucks (TfB) on highways safety improvement proposals for Newton Longville.**

To be deferred pending further discussion with Buckinghamshire Council as a number of aspects are unclear.
